- 1. An applicant must produce for examination a current driving licence (photocard **and** counterpart if appropriate) issued to the applicant under the Road Traffic Acts 1960-1972 or any re-enactment thereof.
- 2. Supply **2** passport size photograph (without sunglasses) for renewal of Drivers Identity Badge. **Renewed annually now.**

NOTE: Drivers who work for any business which is involved in both hackney and private hire operations may make application for a combined licence to drive both types of vehicle.
