CONDITIONS OF APPLICATION

1. An applicant must produce a certificate signed by a registered medical practitioner to the effect that he/she is physically fit to be the driver of a hackney carriage/private hire vehicle. Such certificates are required to be produced every five years up to the age of 60 years and thereafter every 12 months.
2. An applicant must produce for examination a current driving licence (photo card **and** counterpart if appropriate) issued to the applicant under the Road Traffic Acts 1960-1972 or any re-enactment thereof.
3. An applicant must produce his/her birth certificate or passport for examination, together with 4 passport size photographs (without sunglasses) for inclusion on the driver's badge issued by the Council.
4. An applicant must be able to demonstrate that he/she possesses a good working knowledge of the district of Runnymede and the Regulations covering the type of vehicle, or vehicles, for which the application is made.
5. An applicant must provide proof that they have successfully completed a Driving Standards Agency Private hire-hackney carriage assessment.

NOTE: Drivers who work for any business which is involved in both hackney and private hire operations may make application for a combined licence to drive both types of vehicle.
