

Thorpe Neighbourhood Plan

Regulation 18 Decision Statement

1. Background




Figure 1 - Thorpe Neighbourhood Area.

1.1. The Thorpe Neighbourhood Area (as shown in Figure 1 of this statement) and Neighbourhood Forum were designated by the Council on the 24th August 2016 in accordance with Section 61F and 61G of the Town and Country Planning Act 1990.

1.2. The Thorpe Neighbourhood Plan was published for Regulation 14 pre – submission consultation from 8th November to 20th December 2019. The plan was amended by the Forum following the consideration of comments received,

before submission to the Council in June 2020. Regulation 16 consultation on the plan was then carried out from the 7th July to 18th August 2020.

- 1.3. In August 2020, the Council, in consultation with the forum appointed John Slater BA(Hons), DMS, MRTPI as an independent examiner to examine the plan. The purpose of the examination was to determine if the plan had met the basic conditions and other requirements of legislation, including whether the voting area for the referendum should be the neighbourhood area or a wider area.
- 1.4. The examiner decided that a public hearing was not required. Instead the plan was dealt with through the consideration of written representations. The examiner concluded that, subject to making the modifications recommended in his report, the plan would meet the basic conditions and the plan should proceed to referendum. The report also recommended that the area for the referendum should be the Neighbourhood Plan Area.
- 1.5. Regulations 17A and 18 of the Neighbourhood Planning (General) Regulations (2012) (as amended) require the Council to decide whether to reject the Thorpe Neighbourhood Plan or progress it to a referendum, what modifications (if any) to make to it, what the referendum area should be and what action to take in response to the examiner's recommendations. The decisions must be set out in a "decision statement" (this document).

2. The Council's Decision

- 2.1. After careful consideration of each of the modifications recommended by the examiner in his report, and the reasons for them, the Council agrees with all of the recommendations made by the examiner. The Council's reasoning is set out in Table 1.
- 2.2. A complete list of the examiner's recommendations, the actions taken in response to each recommendation and the reason for doing so is included in Table 1 of this statement.
- 2.3. The Council has also decided to progress the modified plan to a referendum of eligible registered voters within the Thorpe Neighbourhood Area, as recommended in the examination report, as the Council agrees that this is the most appropriate area for the referendum.
- 2.4. As outlined by the examiner and Local Government and Police and Crime Commissioners (Coronavirus) (postponement of Elections and Referendums) (England and Wales) Regulations 2020, a referendum cannot be held until at least May 2021.

2.5. This decision has been made by the Corporate Head of Planning Policy and Economic Development through powers delegated by the Council's constitution dated July 2020.
