Englefield Green Village Neighbourhood Plan Submission Consultation (Neighbourhood Planning (General) Regulations 2012 (Regulation 16))

In Autumn 2022, Englefield Green Village Neighbourhood Forum consulted you as part of the presubmission consultation on their draft Neighbourhood Development Plan ('the Plan'). The Forum has now taken all comments into account in finalising the submission version of the Plan, which sets out objectives for the future and contains planning policies to guide development and use of land in the Englefield Green Village Neighbourhood Area.

Copies of representations will be submitted to an independent neighbourhood plan examiner in accordance with Regulation 17 of the Neighbourhood Planning Regulations, for consideration as part of an examination on the Plan. After this stage, further submissions will only be at the request of the examiner, based on the matters and issues he/she identifies through the examination.

Please note that your representation should succinctly cover all the information, evidence and supporting information necessary to support/justify your comment and outline any suggested changes, as there will not normally be a subsequent opportunity to make further representations. The examiner will only be testing whether the Plan proposals meet the 'Basic Conditions' and other relevant legal requirements. Further guidance on the 'Basic Conditions' is available in the National Planning Practice Guidance here: www.gov.uk/guidance/neighbourhood-planning--2#basic-conditions-for-neighbourhood-plan-to-referendum.

Representations may include a request to be notified at a specified email/postal address of the Council's decision under Regulation 19 to 'make' (adopt) the Plan, following successful examination and referendum.


