**Englefield Green Village Neighbourhood Plan Submission Consultation

Englefield Green Village Neighbourhood Forum has prepared a Neighbourhood Development Plan (the Plan) for its area with the help of the local community. The Plan sets out objectives for the future and contains planning policies to guide development and use of land in the Englefield Green Village Neighbourhood Area.

The Forum has recently submitted the Plan and supporting documents to Runnymede Borough Council under Regulation 15 of the Neighbourhood Planning Regulations. All comments (or a summary of them) will be published, and we may publish your name, but contact details will be redacted. Comments submitted about the Neighbourhood Plan and its supporting documents cannot be treated as confidential. Data will be processed and held in accordance with the Data Protection Act 2018.

Copies of representations will be submitted to an independent neighbourhood plan examiner in accordance with the Neighbourhood Planning Regulations for consideration as part of the examination on the Plan proposals. Please note that your representation should succinctly cover all the information, evidence and supporting information necessary to support/justify your comment and outline any suggested changes, as there will not normally be a subsequent opportunity to make further representations. The examiner will only be testing whether the Plan proposals meet the 'Basic Conditions' and other legal requirements - for further guidance on what the Basic Conditions are, please visit the National Planning Practice Guidance at: www.gov.uk/guidance/neighbourhood-planning--2#basic-conditions-for-neighbourhood-plan-to-referendum.

Representations can include a request to be notified at a specified email/postal address of the Council's decision under Regulation 19 to 'make' (adopt) the Plan, following successful examination and referendum.

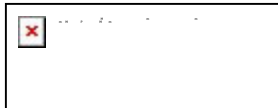
