DRAINAGE MATTERS ENQUIRY 3.3	Sustainable Urban Drainage Systems (SuDS) are drainage systems that are designed to receive rainwater without using public sewers or natural watercourses and manage that rainwater to reduce flood damage, improve water quality, protect and improve the environment, protect health and safety and ensure the stability and durability of drainage systems. They can be simple soakaways or complex interconnected large systems. SuDS systems are encouraged in all new developments by the Flood and Water Management Act 2010, and required in larger schemes.
