This is an application dated 20 July 2015 by Motor Fuel Ltd, owners of and premises licence holders for Thorpe Lea Filling Station, 169 - 171 Thorpe Lea Road, Egham, Surrey TW20 8HP.

The application is to vary the existing Premises Licence under section 34 of the Licensing Act 2003 for the premises known as Thorpe Lea Filling Station. The application is to extend the opening hours for non-licensable activities to 24 hour per day, extend the hours alcohol can be sold to an extra two hours in the morning and remove restrictions on Christmas Day and Good Friday. All conditions already in place to remain.

No representations were received from any Responsible Authorities.

Relevant representations were received from two local residents.

DECISION

The Sub-Committee carefully considered the application, the committee report, including the objections, the submissions of Mr Mitchener, the relevant provisions for the Licensing Act 2003, the March 2015 Amended Statutory Guidance issued under Section 182 of the Licensing Act 2003 and the Council's Licensing Policy (Third Edition) 2011-2016.

The Sub-Committee was satisfied that the licensing objectives - prevention of crime and disorder, public safety, prevention of public nuisance and protection of children from harm - were engaged.

The decision of the Sub-Committee was to grant the Variation of the Premises Licence as per the application and with the conditions already attached to the Premises Licence.

Reasons:

The Sub-Committee considered the conditions already in place were sufficient to address issues which may be raised by the variations sought.

REVIEW

If concerns arise in relation to any of the Licensing Objectives, it is open to any person to apply to have the licence reviewed.

APPEAL


If the Applicant or any person having made a relevant representation is dissatisfied with this decision he or she may appeal against the decision to the Guildford Magistrates' Court, Business Centre, PO Box 36, The Law Courts, Mary Road, Guildford, Surrey GU1 4AS within the period of 21 days beginning with the day on which he or she was notified by the licensing authority of the decision appealed against.
